How it Works:

RFID Tag (small barcode sticker) will be adhered to your vehicle's windshield behind the mirror. Each time you pull up to our pay station, an electronic eye will read the RFID tag & the gate arm will automatically open allowing you to enter the car wash. Valid for one car wash per day for designated vehicle.

A minimum **3-month contract** is required with of signing this Agreement.

Terms and Conditions

- 1. Commercial vehicles / Fleet vehicles / Taxis do not qualify for the Wash Club.
- 2. Registered vehicle must have a White Water Express RFID (Radio Frequency Identification) sticker tag affixed to windshield behind the mirror to get a car wash. A damaged RFID tag must be reported to White Water Express Car Wash, LLC immediately. Any attempt to remove the tag will destroy it and will keep it from operating. Member will be charged for the tag replacement.
- 3. Valid credit card required to participate in program.
- 4. Payment for initial 3 month period is non-refundable.
- 5. After **initial 3 month period**, this Agreement will automatically be extended on a month-to-month basis unless Member provides the White Water Express Car Wash manager with a notice of cancellation.
- 6. Unless terminated or cancelled, after the initial 3 month period Member's credit card will be charged the selected monthly Wash Club fee on the first day of the monthly period. If a credit card charge is rejected for any reason or the monthly payment is not otherwise paid on the first day of the monthly period, this Agreement will automatically be terminated.
- 7. Vehicles must conform to White Water Express Car Wash standards. Modifications outside of our standards to existing customer's vehicle may require program termination. Please see White Water Express Car Wash manager for confirmation that vehicle meets standards.
- 8. Stickers remain the exclusive property of White Water Express Car Wash and must be surrendered upon termination. In the event that windshield sticker is tampered with or the program is used in any way inconsistent with its terms and condition, this Agreement will be immediately terminated and all monies will be forfeited. Failure to return any and all stickers at the termination or cancellation of this Agreement will result in a charge to the Member's credit card for the replacement cost of such stickers.
- 9. No other coupons or special offers may be combined with the unlimited pass at any time.
- 10. Pricing and Terms & Conditions are subject to change at any time without notice.
- 11. White Water Express Car Wash reserves the right to terminate any membership at any time without notice.
- 12. No refunds for time that was not used, days that we close early or do not open due to weather or equipment maintenance.
